

No one had ever mentioned the lack of seating to the City Manager before Roshan acknowledged the need and made the request.

NEW Sausalito Municipal Code

The Sausalito City Council recently adopted an ordinance entitled "Peddlers and Door-to-Door Solicitation." This new ordinance, Section 13.20 of the Sausalito Municipal Code, was introduced on July 18 and adopted on July 26. The new law will take effect on August 26, thirty days after adoption.

The new ordinance will prohibit knocking on doors or otherwise disturbing residents who have a "no solicitation" or similar sign posted on their property. This provision will be an effective tool in preventing intrusions into residents' privacy by those seeking to solicit funds, and will allow police officers to issue citations to those who are in violation. This type of provision has been upheld by the courts as "content neutral," meaning that it applies to anyone seeking to go door-to-door, regardless of whether the person is seeking only to distribute information, solicit funds, or engage in a commercial transaction.

The ordinance limits door-to-door solicitation to the hours between 8:00 a.m. and 7:00 p.m., or a half hour after sunset, whichever may come first. The ordinance also requires "peddlers" to obtain a permit from the Sausalito Police Department prior to any activity. This ordinance does not regulate constitutionally protected religious or political door-to-door speech.

Included in this ordinance are regulations on mobile vending units like food trucks and ice cream carts. This includes regulations on hours of operation and parking and standing within the city limits, and generally prohibits sales from fixed locations on City sidewalks or other public places.

Exempt from the ordinance are private yard or garage sales and the sale of newspapers. The Sausalito Police Department encourages residents who do not want to be disturbed by door-to-door solicitors to post a "no solicitation" or similar sign in their front yard.

Lending the City and our neighbors, a helping hand



At Age Friendly Sausalito's request, the City's Department of Public Works initiated the Pedestrian Flag Program along Bridgeway. To provide the monitoring and publicity necessary, members of Age Friendly and Sausalito Village will be taking over the program as of SEPTEMBER 12th. Focus will be on three of the most dangerous crosswalks: Second/Main, Bridgeway/San Carlos and Bridgeway/Napa. Here are the simple instructions to safely using the flags:

- 1. Hold flag high and point in the direction across the street
- Step 12" into crosswalk to let drivers know you are crossing
- 3. Make eye contact with Driver when they slow down to ensure they see you and come to a complete stop
- Begin to cross the street and look in the opposite direction to make eye contact with Driver on other side to ensure they stop
- Return flag to container on the pole once you have crossed



The monitoring team will help to redistribute flags and monitor the need for replacements. A team of volunteers will be assembling flags on Sunday, September 11th.

RESULTS ARE IN.....



Thanks so much to everyone who took the time to complete the Member Survey. Here are some of the things we learned....

- o 51% of members learned about SV through friends, family, neighbors and 32% learned about SV by attending an event
- o 61% joined to be able to remain in their homes, 55% to meet new people and enjoy the events,23% to receive assistance and 41% to volunteer
- 84% are happy with the changes to the Weekly Calendar Update and Newsletter
- 60% visit the web site
- Top activities members are interested in that would be new to SV include Tai Chi (coming!), Going to the movies, Going to cultural events, Meditation, Bridge, Mah Jong, Hiking (happening!)
- o 52% have attended a Monthly Meet and 58% have gone on a trip
- o 19% of members describe their health as excellent, 69% as good, 10% as fair, 2% as poor
- 53% are familiar with the Health Care Advocacy Committee, 33% are not and the rest were interested in hearing more (these members have been contacted)

All of the information that we learned through your responses are helping us move the Village in the direction that better meets the needs of members. As an early result of the survey, hiking activities have started and a new Tai Chi class and dance class are in the works.

Members who were interested in specific activities have been contacted via email to identify members interested in hosting activities. Members who stated that they would like to learn more on specific topics have all been contacted as well.

Living Room Chats have started up again to introduce more residents to the Village. Thank you to those who offered to host a Chat in the coming months.
